It was observed that the service lines #2 and #1 have a water leak. Work orders already done.
Repair leak in service line #1 and #1

Violation #56. Ventilation & lighting
At time of the inspection, it was observed that some panels under hood are rusty.
Replace rusty panels under hood.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
